If you do decide to leave a gift to Earth Trust, we suggest you include the following sample wording in your will to ensure your gift is valid. (You may wish to discuss the following wording with your solicitor).

I give to Earth Trust (Charity Registration No. 1095057), Little Wittenham, Abingdon, Oxfordshire, OX14 4QZ for its general charitable purposes.

Frequently Asked Questions

How and why should I make a will?

If you don't have a will, your estate will be divided according to the law when you die. This could mean that your wishes are not carried out as you would want them to be. Having a will, especially one written by a solicitor, is the only way of ensuring that your loved ones and chosen charities will be remembered as you wish.

What kind of gift could I make?

There are three main types of gift that you can leave in your will:

- 1. A percentage of your estate can make a big difference. You can leave a percentage of your estate after your family and friends are provided for. This is called a residuary gift.
- 2. You can leave a pecuniary gift which is a fixed sum of money.
- 3. Or you could leave a specific gift such as a piece of jewellery or art etc.

How will my gift be used?

It has never been more critical to provide access to green space and to engage people deeply with nature – both for their own wellbeing and to inspire action to protect the natural world for the future.

Your legacy can live on for generations and will help us continue our vital work to help champion accessible green spaces for everyone. A gift in your will can help build a world where people and nature thrive in harmony.

Can I reduce inheritance tax by leaving a gift to charity?

By leaving a gift to a charity, you may also be able to reduce the amount of inheritance tax due, enabling more of your assets to go to your beneficiaries. If you leave 10% or more of your estate to charity in your will then the overall amount of inheritance tax you have to pay will reduce from 40% to 36%.

I've already made a will. Do I need to make a new one?

If you already have a will and you want to add the Earth Trust as a beneficiary, you simply need to ask your solicitor to help you complete a basic form called a codicil – we have a template that you can use. If you don't yet have a will, you shouldn't fill in this form. Your solicitor will be able to advise you on how to include your gift to the Earth Trust in your new will.

I don't have a will. How do I find a solicitor?

We would encourage you to discuss your will with your solicitor to ensure that all legal requirements are met and that your will is valid. A properly drafted will can help reduce the amount of tax payable on your estate and increase the value of the assets that you pass on to the people you care about.
